AVAILABILITY

Available to all farm and residential consumers for all uses subject to the Cooperative's established Rules and Regulations.

TYPE OF SERVICE

Single-phase, 60 hertz, at the Cooperative's standard secondary voltages.

RATE-MONTHLY

Generation and Transmission Service

Energy Charge
All kWh @ \$0.07565 per kWh

Distribution Service

Base Charge @ \$37.00 per month
Energy Charge
All kWh @ \$0.03903 per kWh

MINIMUM MONTHLY CHARGE

The monthly minimum charge shall be the Base Charge plus applicable adjustments. Payment of the minimum charge does not entitle the consumer to any kilowatt-hours.

Whenever a consumer applies for reconnection of service at the same location within a twelve-month period of the time the service was disconnected at the consumer's request, a charge equal to the sum of the monthly base charge indicated above for each month disconnected may be required before reconnection is made.

WHOLESALE POWER COST ADJUSTMENT

Billing for energy delivered under this schedule will be adjusted up or down by the amount, to the nearest 1/10 mill (\$0.0001) by which the Cooperative's cost of purchased power per kWh purchased during the preceding month exceeds, or is less than 69.44 mills (\$0.06944), provided that such amount be adjusted for line losses. The actual cost of power during that month may be adjusted to reflect the current wholesale fuel adjustment charge.

TAX PROVISION

All non-federal government and non-exempt consumers served hereunder shall be assessed and billed an energy excise tax in accordance with Schedule EET.

The consumer shall also pay in addition to all other amounts provided herein any other sales, use, franchise, gross receipts, utility, excise, or other tax now or hereafter applicable to the service rendered hereunder or imposed on the Cooperative as a result of such service; provided, however, that no such tax shall be included in the monthly charge if the consumer has furnished to the Cooperative satisfactory evidence of the Cooperative's exemption from liability for such tax.

TERMS OF PAYMENT

The above rates are net. The net amount is due and payable on the due date stated on the bill. If the total net bill as computed above is not paid by the due date, the net bill will be increased by seven percent (7%) and such gross amount will be immediately due and payable.

SEASONAL SERVICE

Consumers desiring intermittent service may be served under this schedule on an annual basis. The annual minimum shall be \$444.00 plus \$24.00 per required transformer kVA capacity in excess of 10 kVA plus applicable adjustments. The minimum annual charge shall be payable in advance of the connection.
